



CREDIT AGREEMENT

It is understood and agreed that in the event L.H. Gault & Son (LHG) extends credit to the undersigned, it shall do so in reliance upon the representations made on a credit application by the undersigned of even date. If credit is extended, it shall be at the times and in the amounts determined by LHG. Extension of credit and/or sale of product/materials may be terminated by LHG at its sole discretion at any time without prior notice. Credit approval may be subject to a credit check.

In consideration of the granting of credit, the undersigned agree that all purchases will be made subject to the following terms of sale:

- Payment Due Date:** Statements are mailed each month and the balance shown is due within 30 days of the billing date unless otherwise agreed upon in writing.
- Service (finance) Charge:** A service charge (designated a "finance" charge) of 1.5% per month (ANNUAL PERCENTAGE RATE of 18%) accrues on amounts outstanding over 30 days until paid. Service (finance) charges accrued but not billed will be charged on the next statement rendered if not previously paid with the past due balance. The charge of 1.5% will continue for each 30 day increment until balance is paid. The monthly charge of 1.5% will continue after a court judgment on an action to collect amounts due, foreclosure on a mechanic's lien or mortgage or otherwise obtain payment until any amounts due are paid in full.
- LHG reserves the right to begin legal action at any time after the payment due date to collect outstanding account balances. Although designated a "finance" charge as required by regulations of the Connecticut Banking Commissioner, the monthly service charge does not entitle the purchaser to defer payment beyond the due date. If the account is referred to any attorney or collection agency for collection, the purchaser is responsible for all costs of collection including reasonable attorney's fees as limited by law and the court. The purchaser shall be responsible for reasonable attorney's fees incurred in actions to foreclose mechanic's liens and judgment liens.
- Payment of any and all amounts charged on the account is guaranteed by the undersigned.
